

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the FERMI NATIONAL ACCELERATOR LABORATORY HEALTH AND WELFARE BENEFITS PLAN, EIN 57-1239010, Plan No. 514, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Blue Cross Blue Shield Of Illinois, Blue Cross Blue Shield Of Illinois, Delta Dental Of Illinois, Express Scripts, Eyemed, and Metropolitan Life Insurance Company to pay health, dental, vision, life insurance, long-term disability, prescription drug, stop loss, HMO, PPO and Flex AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2022 were \$31,084,853.
